


What has continued for 150 years since has established the Fremantle Chamber of Commerce as a critical business representative body for the Greater Fremantle Region!

My exciting new chapter as the CEO of the Fremantle Chamber of Commerce (FCC) commenced in March this year and I have been warmly welcomed by the Fremantle community.

My first months have been busier than ever ensuring that we are there side by side with our members, creating a sense of community and authentic support.

Meeting our FCC members has been an absolute highlight and I thank them for sharing feedback and offering suggestions on how we can reimagine our Chamber support.

The FCC team and our stakeholders (including Mayor Hannah Fitzhardinge) have tucked me under their wings. Since I arrived home just months ago, I have had the pleasure of...

I also intend to develop the FCC's fiscal reliance and





I'm proud we have adopted a reserved policy to further strengthen our financial position. I also intend to support innovation into our City at a time when our members need it most.

I'm also proud the 2023 Business Awards will be back to where it was best! With a rich history dating back to 1850 the The Esplanade Hotel Fremantle is an iconic landmark in Western Australia and the perfect home for the our prestigious awards on-going.

Export Report – FCC Export Manager Marian Bull

International Trade & Export Documentation

The Fremantle Chamber of Commerce is one of Australia's oldest Chambers of Commerce, founded in 1873, to support the needs of traders, merchants and shipping agents.

We are an authorised and experienced export documentation agent, providing Non-Preferential (Certificates of Australian Origin), Preferential (Free Trade Agreements) and other associated documentation. We work closely with the Australian Chamber of Commerce and Industry to advocate and represent our exporters on a national stage.

Based in the heart of Fremantle Port City's diverse business community, we offer a unique and customised manual and e-certification service tailored to a range of exporters.

The start of the year July 2022 was slightly below target with the number of certificates issued 10% down on the previous July, however this rebounded the following three months in number and revenue.

The Christmas period of November and December 2022, was significantly lower in number of certificates issued and revenue due to the devastating floods in the Eastern States affecting the wheat exports. The War in the Ukraine also severely upset the supply chain. The average freight rates for March were 32% down Year on Year.

Trade restrictions on live lobster to China were expected to be lifted in January 2023, however, it never eventuated. The positive story was that wheat exports rebounded in March and continued (together with an increase in the exports of lentils to Pakistan) and this resulted in our better-than-expected targets being met.

The continual downward trend of sea and airfreight costs, plus the increase in flight numbers in and out of Australia (together with new vessels being added to the Australian schedules) will assist in a recovery in the supply chain. This is reflected in the increase in FCC revenue for May (18%) and June (24%) above target.

Our FCC Export offering is competitive, our level of service is expedient and trusted.



We're going to focus on lifting loyalty to the Chamber and we plan to double the number of events we do, uch as short workshops, courses to advance your career, peed networking and seminars that focus on achieving wordessional goals. Freo's business Logies gives power to the people

The Fremantle Chamber of Commerce has taken a leaf from The Logies and put its celebrated business awards in the hands of the voting public.

People will be able to nominate and vote across 15 categories, including for their favourite Fremantle entertainment venue, cafe or restaurant, retail store, tourist attraction and more.

It's a significant change for the annual awards unveiled as part of the chamber's 150th anniversary.

Chamber chief executive Chrissie Maus hoped the new approach would unearth the love for hidden gems, and old and new businesses in Fremantle, South Fremantle, East Fremantle and Cockburn.

"Our iconic port precinct is a veritable smorgasbord of vibrant indulgences, which is what makes it so hard to declare the cream of our Freo crop, however we are going to do it anyway because you deserve to know who's raising the bar for food, booze, beauty and more in WA's most beloved precinct," Ms Maus said.

Old Bridge Cellars was last year's big winner, named Fremantle business of the year after also taking out the retail category for the second time.


Other categories that will be awarded in October include accommodation, bar, marine and business engineering, and service enterprises, sustainable enterprise, hair and beauty, health and wellness, international trade, creative industries, and property development. Businesses older than 10 years can be nominated for the chamber's Hall of Fame.

The process of nominating a business is also in the hands of the public and begins this Tuesday, August 1.

Fremantle mayor Hannah Fitzhardinge said giving people a vote on behalf of their favourite business was a Fremantle thing to do.

"The passion that people feel for everything Fremantle includes our businesses," she said.

Notes To The Financial Statements

1. Introduction

The financial statements cover The Fremantle Chamber of Commerce Inc as an individual entity. The Fremantle Chamber of Commerce Inc is a not-for-profit Association incorporated in Western Australia under the Associations Incorporations Act (WA) 2015 ('the Act').

The functional and presentation currency of The Fremantle Chamber of Commerce Inc is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

2. Basis Of Preparation

In the opinion of the committee of management, the Association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

3. Summary Of Significant Accounting Policies

a. Income tax

The Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

b. Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payable are stated inclusive of GST.

Cash flows in the Statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

c. Property, plant and equipment

Land and buildings

Land and buildings are measured using the revaluation model.

Plant and equipment

Plant and equipment are measured using the cost model.

Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

d. Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

e. Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.



Treasurer's Report Headlines

Income

- With reference to the 'Statement of Cash Flows', it should be noted there remains a cash balance at year-end.
- The results show a 8.99% decrease in total revenue across the last 12 months, which have been offset slightly by increases to Export Certification (5.98%) and Property Income (6.95%).
- The Fremantle Chamber of Commerce Boardroom and vacant suites were hired out for meetings and workshops. This delivered a positive increase in 2022:23 with elevated bookings across the year.

Expenses

- The results show an increase of \$2,226 from the previous year. Urgent building fixes (including asbestos removal) and other urgent fixes also resulted in a loss of tenant (income).
- It should be noted that with a new CEO being appointed this has heralded a detailed review and analysis of all FCO expenditure. We are already seeing the benefits in cost-savings, which will enhance the cash position during FY24.
- Further investment was made to strengthen our digital data against cyber attack.

Assets

- Receivables (being primarily membership fees) remain similar to the prior year, it should be noted a full review of members was performed in FY23 by the new CEO.
- · Increase to Capital Improvements of \$57,286.
- Increase to Computer Equipment of \$9,953 (new staff laptops) (two being almost 10 years old).
- Increases have been funded from cash reserves, albeit The Chamber continues to seek sponsorships and grants on an annual basis.

Liabilities

- · Trade payables remain similar to previous years.
- Borrowings (being the "Bank Loan" previously held as "Cash") has been paid down but is able to be redrawn should it be required.
- FY24 Budget: We anticipate a small Net Profit with cashflow to be impacted by the need for ongoing Capital Works.

FCC Reserve Policy: Our Financial Sustainability Set

Policy Statement

The FCC has set aside a financial reserve in order to:

- · Protect and safeguard assets;
- · Allow for payment delays and changing reporting requirements;
- Strengthen the FCC liquidity ratios;
- · Meet all liabilities as they fall;
- Provide greater resilience and greater capacity for unforeseen difficulties or economic conditions;
- · Protect staff OH&S and culture; and
- Deliver against the FCC strategic vision.

The FCC's Reserve Policy is modelled on the Australian Institute of Company Directors and means the amount FCC has provisioned is in a separate provisioned account.

This reserve cannot be touched unless triggered and would only be used in extreme circumstances.

Ratified triggers to unlock the FCC reserve policy

- Permission to access the reserve provision has to be a majority vote put to directors at a board meeting or via a circle resolution.
- The reserve provision can be used for paying out current or noncurrent liabilities.
- The reserve provision can be used for emergency marketing or support activities, subject to economic needs and directors approval.
- The reserve provision can be used for contracting of legal or outside experts (subject to point 1, directors approval and for approved purposes).
- Reserve funds could be used for disaster relief or unforeseen events (subject to point 1, directors approval).
- The reserve provision can be used at the discretion of the CEO (subject to point 1, directors approval).
